




**HAMILTON COUNTY COMMISSIONER'S COURT

**NOTICE OF 2025 TAX YEAR
PROPOSED PROPERTY TAX RATE FOR
HAMILTON COUNTY, TEXAS**

A tax rate of \$.3930 per \$100 valuation for Maintenance and Operations and \$.0210 per \$100 valuation for our Debt Service Tax Rate for a Total Tax Rate of \$.4140 per \$100 valuation has been proposed by the governing body of Hamilton County, Texas.

The No New Revenue Tax Rate is the total tax rate needed to raise the same amount of property tax revenue for Hamilton County, Texas from the same properties in both the 2024 tax year and the 2025 tax year.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:

Property Tax Amount = (tax rate) X (taxable value of your property)/100
