8. Discuss and-or Action-Budget Workshop

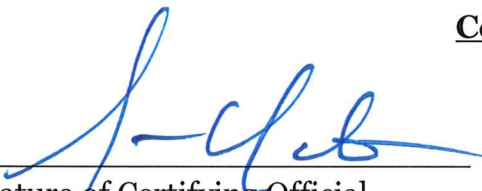

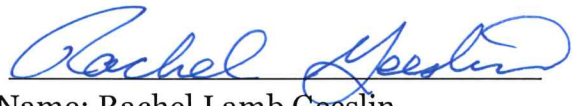

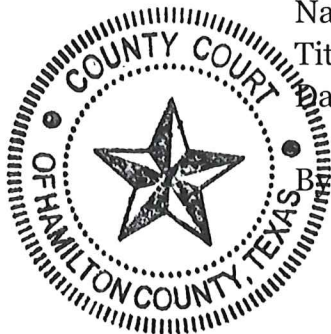
