First Street, Hico, Texas, for all persons interested in the above proposed voluntary annexation. At said time and place all such persons shall have the right to appear and be heard. Of all said matters and things, all persons interested in the things and matters herein mentioned, will take notice.

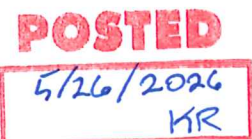

**A RESOLUTION SETTING A DATE, TIME, AND PLACE FOR A PUBLIC HEARING ON THE PROPOSED ANNEXATION OF CERTAIN PROPERTY BY THE CITY OF HICO, TEXAS, AND AUTHORIZING AND DIRECTING THE MAYOR TO PUBLISH NOTICE OF SUCH PUBLIC HEARING.**


**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HICO, TEXAS:**

**SECTION 1:** On the 8<sup>th</sup> day of June, 2026, at 5:30 p.m. in the City Council Chamber of the City Hall of the City of Hico, Texas, the City Council will hold a public hearing giving all interested persons the right to appear and be heard on the proposed annexation by the City of Hico, Texas of the following described property, to-wit:


Being all that certain tract or parcel of land situated in Abstract No. 888 in the Mary Woods Survey, Tract 7.685, containing 1 acres, more or less, Hamilton County, Texas, as more particularly described in Exhibit 1, attached hereto.
